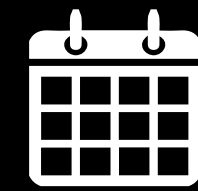

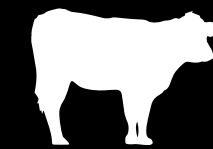

Over the course of the year, the student gains knowledge on financial responsibility and time management by caring for the animal. For participants, this program is an opportunity to learn about the livestock industry and to potentially start their own investments.

All contributors have the opportunity to purchase reserved seat rodeo tickets in advance of the public at \$36 per ticket. There is no limit on the quantity of tickets a contributor may purchase for the rodeo performance on the day of the Ultimate Scramble Championship. In addition to the above benefits, all contributors at \$500 or above will receive a plaque or gift. Contributors who submit full payment by the deadline will be recognized on the big screen during the rodeo performance. All benefits have a deadline upon which benefits are no longer made available to contributors. Benefits are made available to contributor only after full payment has been received by Rodeo Austin. The deadline for full payment is January 15, 2019. All benefits (i.e. tickets, passes, etc.) will be delivered by Rodeo Austin to contributor at the address identified by contributor on the reverse side of this form. Payment will not be accepted without the Ultimate Scramble Championship Donation form attached and delivered to the Rodeo Austin, 9100 Decker Lake Road, Austin, Texas 78724. Should the scrambler choose not to use their certificate, the donation will be used in the general calf scramble fund. Rodeo Austin is a 501(c)(3) non-profit organization. The goods or services provided in exchange for your cash payment has value and the payment less the value may be deductible for federal income tax purposes as a charitable contribution. The value per contributor level is as follows: \$6,000 contribution (value of \$1,017), \$5,000 contribution (value of \$911), \$4,000 contribution (value of \$805), \$3,000 contribution (value of \$674), \$2,500 contribution (value of \$568), \$2,000 contribution (value of \$462), \$1,500 contribution (value of \$186), \$1,000 contribution (value of \$80), and \$500 contribution (value of \$40).
