TEAM REGISTRATION

TEAM REQUIREMENTS

- All registrations must be **paid in full** by **January 12th, 2026**.
- Each team consists of one (1) unique Chief Cook and up to two (2) Assistant Chief Cooks.
- Each Chief Cook is required to have their own BBQ pit and will be solely responsible for their space, team guests, and compliance with Rodeo Austin and BBQ Austin rules and regulations.
- The Chief Cook at the event must match the team's registration.
 - If there is a change in the Chief Cook who registered prior to the event, please email the BBQ Austin Representative at bbqaustin@rodeoaustin.com.

REGISTRATION OPTIONS

Teams are encouraged to register online at rodeoaustin.com/events/bbq-austin/. Registration will not be final and team spaces will not be assigned unless full payment has been received by Rodeo Austin. Spaces are assigned based on the size of the package purchased during registration and fundraising efforts. All mailed payments/documents must be received by the office by the registration deadline. Debit/credit card payments are subject to a credit card processing fee.

TEAM SPACE INFORMATION

LOAD-IN

Tent set-up begins **Monday, March 2, 2026**. Tent companies must coordinate with Shayne Lockhart (bbqstfr@gmail.com), and a team representative must be present during installation.

Each team is allowed one vehicle during load-in hours per space with a 30-minute unloading window before moving to designated parking lot. **NO VEHICLES ALLOWED IN SPACE PAST 9:00 PM on Thursday, March 6th.**

- Load-in begins **Tuesday, March 3 at 8:00 AM – Thursday, March 5 at 9:00 PM**. Early load-in is not allowed.
- All teams must be on-site by **Thursday, March 6 at 9:00 PM**. All vehicles must be removed from the competition area. No vehicles permitted in space. Approved RVs only in the competition area.

UPON SITE ARRIVAL

- Know your team space number before arrival.
- Enter through **Gate 2 off Decker Lane** — public gates will not be open.
- Chief Cooks and/or team representatives will receive an onsite registration packet upon arrival at Gate 2.
- RVs must check in upon arrival to receive their RV tag. Tags must be properly displayed at all times.
- Confirm in advance if your RV will be parked in your team space or in the reserved RV lot.
- Unregistered RVs (not purchased during registration) will not be permitted on-site.
- A BBQ Austin representative will escort you to your designated team space upon arrival.

SPACE INSPECTION

All teams will receive a health inspection by Austin/Travis County Health Officials and a fire safety inspection by the Fire Marshal **no later than noon on Friday, March 6, 2026**.

LOAD-OUT

Load-out begins after the Awards Ceremony on **Sunday, March 8, 2026** and must be completed by **6:00 PM**. Gates will remain closed until the ceremony concludes.

Important Reminders:

- No late load-out is permitted.
- Teams may not stay overnight on Sunday.
- Your space must be left clean and in its original condition.
- Any leftover items, debris, or trash will result in a \$500 fine.

ELECTRICAL

BBQ Austin provides power equipment for team spaces. While these units may have multiple outlets, only designated outlets may be used for safety and proper power distribution.

Setup Tips:

- Bring a 100–150 ft. extension cord (minimum) — all cords must be 12-3 gauge with ground.
- A 30-amp power adapter is recommended.

If More Power Is Needed:

- Teams may bring a personal generator, which must be properly grounded and will be inspected by the Fire Marshal.
- BBQ Austin does not provide fuel, service, or maintenance.
- Vent generator exhaust upward for safety and airflow.
- Each generator must have a dedicated fire extinguisher on site.

GREASE & ASH DISPOSAL

To keep the event clean, safe, and environmentally responsible, please follow these guidelines:

Grease:

- Collect used cooking oils and fats in a secure container provided by your team and take them to the designated grease receptacles. **Do not** pour grease into trash bins, sewers, or portable toilets. Improper disposal may result in removal from the event.

Hot Coals:

- **Never** place hot coals on the ground or in trash cans. Once cooled, transfer them to the ash bins located in the designated disposal area for safe handling.

TRASH INFORMATION

Each team space will include a few trash bins. Teams are responsible for:

- Monitoring and replacing trash bags as they fill.
- Supplying their own 55-gallon industrial trash bags.
- Placing full bags at the front of your tent for pickup.

OPEN FIRES

For safety reasons, social fires, open fires, and ground pits are **strictly prohibited** anywhere on the event grounds.

WATER STATIONS

Teams in packages B through G will have access to designated water trees for use throughout the event. In addition, limited community water fill stations will be available to all teams. To make the most of these resources, please bring your own containers and/or hoses to transport water to your area. However, hoses may not be run directly from the communal water stations to your team space. To ensure fair access for all, please limit your use of the community water faucets to 10 minutes at a time. As part of health and safety requirements, each team must have a bucket of water or another approved sterilizing agent located in their cooking area. *Please note that water will not be delivered to individual team spaces.

ICE TICKETS

Ice is available for purchase at \$8.00 per 20 lb. bag. Ice tickets are required for all purchases.

It's highly recommended to order ice tickets in advance during registration. Additional tickets may be purchased onsite from the BBQ Austin Bank during the event.

- No outside ice trucks are permitted on the BBQ Austin grounds.

PORTABLES, HANDWASHING & GREY WATER RENTALS

All standard and ADA restrooms, handwashing stations, and grey water tanks must be rented through BBQ Austin's approved vendor. Outside rentals are not permitted. VIP trailers will need approval from BBQ Austin to be permitted on grounds, services for restroom trailers must be through Rodeo Austin official waste provider.

- Grey water must be disposed of in the designated tanks only. Dumping elsewhere will result in disqualification.
- Units will be placed in your team space before Load-In. You may move them, but keep them accessible and uncluttered for servicing. Units not easily accessible to the service trucks will not be serviced.
- Service takes place **3:00 AM–10:00 AM Thursday through Sunday**. Inaccessible units (gated, blocked, locked, etc.) will not be serviced.

- 100 People = 3 Portables
- 150 People = 4 Portables
- 250 People = 6 Portables
- 500 People = 7 Portables
- 1,000 People = 12 Portables

PERSONAL TENT INFO

Teams may bring and set up personal pop-up or easy-up canopies up to 100 sq. ft. without using a commercial tent company.

- No staking or digging is allowed anywhere on the event grounds (grass or pavement).
- It's recommended to weigh down all sides of your canopy for stability.
- Any damage to the ground in your team space will be the team's responsibility, and necessary repairs will be determined by BBQ Austin.
- All tents and canopies must be flame-retardant. Keep the certificate or documentation validating flame retardancy inside the tent at all times for inspection.

TENTS

The Travis County Fire Marshal requires a temporary permit for:

- Tents over 400 sq. ft. with sides
- Tents over 700 sq. ft. without sides

If your tent does not exceed these sizes, a permit is not required. The permit fee is \$240 and is due at registration. **Inspections will take place before noon on Friday, March 6, 2026.** Teams will not be allowed to operate without a permit. If renting a tent, all tents and canopies must be flame-retardant. Keep the flame-retardancy certificate inside the tent at all times for inspection. BBQ Austin partners with Bright Event Rentals for rental needs.

TEAM SPACE RULES & REGULATIONS

ADMISSIONS/EVENT SECURITY

BBQ Austin provides security on the contest grounds from Tuesday through Sunday, during both open and closed hours.

While security will be present, BBQ Austin cannot guarantee the safety of team spaces, property, or guests and is not liable for any damage or incidents beyond its control.

If any security issues arise, call the phone number provided in your team information packet upon arrival.

TEAM SECURITY

Teams may provide their own staff to help manage entry to their space; however, all team security must be unarmed and hired or supplied by the team.

- Armed guards are not permitted, and no weapons are allowed anywhere on the event grounds.

BEVERAGES/ALCOHOL

- Teams, guests, and individuals may bring beverages onto the property **only until 9:00 PM on Thursday**. After this time, **no outside beverages may be brought in**.
- Teams may not sell or require donations for alcoholic beverages, but they may encourage voluntary contributions to donation buckets.
- Any team serving alcohol must use a sufficient number of TABC-certified bartenders and provide food while alcohol is being served.
- Excessive alcohol use may result in disqualification.
- No one under 21 may be served alcohol under any circumstances. Violations may result in arrest and penalties from BBQ Austin.
- BBQ Austin is a licensed venue; only beverages served on-site are permitted on the grounds.

EVENT ACCESSIBILITY

ADA parking is available in the General Public Parking lot. No additional ADA transportation, personal care, push service, or wheelchair rentals are provided.

Most event grounds are paved, but some team and public areas include grass or uneven terrain. We strive to make the event as accessible as possible, though certain areas may be harder to navigate.

PROHIBITED ACTIONS

Bag checks will be conducted at all public gates during operating hours. Teams are not permitted to bring items through public entrances and must use Gate 2 for any restocking. Shoes and shirts must be worn, and clothing with political or discriminatory content is not allowed.

- Unmanned aerial vehicles, aircraft, and drones are strictly prohibited.
- Any activities that disturb neighboring teams, including flashing lights, excessive noise, blocking walkways, or restricting access, will not be tolerated.
- Quiet hours are from Midnight to 8:00 AM.

PROHIBITED ITEMS

The following items and activities are not permitted anywhere on the event grounds:

- Firearms, explosives, or weapons of any kind (including concealed carry)
- Illegal substances
- Drones, quadcopters, or other flying objects
- Live animals or pets
- Transportation equipment other than vehicles
- Obscene or inappropriate music
- Golf carts, Gators, motorized coolers
- Glass Bottles
- 3- or 4-wheelers, motorcycles, bicycles
- Rickshaws, skateboards, rollerblades
- Scooters (manual or electric), Segway's, hoverboards

DISTRIBUTION OF FOOD/GOODS/SERVICES

Teams may not distribute goods or services to the general public. This includes items such as team merchandise, informational materials, pamphlets, or marketing content.

Food sales are not permitted. This is a donation-only event, and teams are encouraged to collect voluntary donations for any food or drinks they provide. All funds collected directly support the mission of Rodeo Austin.

SIGNAGE/MARKETING/SPONSORSHIP

Teams are asked not to display promotional signage or decorations within their space. Handing out marketing materials, literature, or branded items to the public is not permitted. If your team is interested in selling products or promoting a brand, you may explore becoming an approved vendor through BBQ Austin. For more information, refer to the *Rodeo Austin Marketing Guidelines on page 24*.

TEAM SPONSORS

BBQ Austin understands and supports the importance of team sponsorships. To respect our event partnerships, teams may recognize their sponsors in the following ways:

- If a team sponsor conflicts with an exclusive event sponsor, signage may be displayed inside the team space but not visible to the public (for example, inside the tent).
- All other sponsor signage may be displayed within the team space and can be visible to the public as long as it remains inside your designated area.

EMERGENCY

IN CASE OF AN EMERGENCY, DIAL [512-919-3050](tel:512-919-3050)

- There will be Medical and Law Enforcement onsite 24/7.
- If someone in your tent is having an emergency, clear the area, call for help and remain calm.
- If you call for help, have a representative from your team go out to the alley and watch for emergency personnel to help direct them as quickly as possible.

VEHICLES/PARKING/ADMISSION

BRINGING AN RV?

- You are encouraged to fill your water tank before arriving on-site.
- All RVs must have a completed RV form prior to arrival, whether parked in your team space or the designated RV lot.
- **Onsite RV permits will not be available for purchase.**
- RV services (tank dumping and water filling) must be scheduled and paid for by January 12, 2026.
- If renting an RV, ensure the delivery person has your information and a team representative is present to accept delivery.
- RVs cannot be removed until after the Awards Ceremony on Sunday, March 8, 2026.
- The Travis County Fire Marshal requires a 10 ft. distance between pull-behinds and other structures, and a 20 ft. distance between drivable RVs and structures.

BAND ADMISSION & PARKING

Band vehicles may enter through **Gate 2** and will be directed to the designated unloading area. BBQ Austin volunteers will assist with unloading and escorting bands into the event area. Vehicles will remain parked in the band lot while on-site.

- Each band or sound crew member must have a band ticket, included in the team packet, via email or available for pickup at the Rodeo Austin office. Teams are responsible for ensuring all members are properly ticketed.
- Music, bands, and sound equipment **must be set up by 8:00 PM on days of the event.**
- Anyone in the vehicle who is not part of the band must have a valid ticket or wristband and walk to the team space. The load-in/out process is reserved for band members only.

DISCOUNTED TICKETS FOR TEAMS

Teams may purchase *discounted* parking and single-entry tickets during registration:

- **Adults:** \$8
- **Children** (ages 3–12): \$5
- **Parking:** \$15

Tickets are required for entry starting at 11:00 AM on Friday, March 6, 2026.

All tickets are non-refundable and non-transferable and may not be resold.

TICKETS & TEAM SPACES

If your team creates a ticket or invitation for entry into your specific space, it must include the following disclaimer:

“THIS IS NOT AN ENTRY TICKET INTO BBQ AUSTIN GROUNDS.”

Preferred wording:

“This ticket/invitation/wristband grants access only to Space #___ / Team ___ and is not valid for entry into BBQ Austin grounds.”

CONTEST INFORMATION

CHAMPIONS BARBECUE ALLIANCE

BBQ Austin follows all Champions Barbecue Alliance (CBA) regulations and requirements unless otherwise noted in this handbook. For a complete list of CBA rules, visit www.cbabbq.com.

CHIEF COOK MEETING

The Chief Cook Meeting will take place at 5:00 PM on Thursday, March 5, 2026.

NEW!

During this meeting, the BBQ Austin Committee Leadership and CBA Event Representatives will review contest rules, turn-in times, and product quantities. They will also answer any questions you have about turn-ins. Attendance is mandatory for all Chief Cooks or an appointed representative. At this time, Chief Cooks will also pick up competition containers, receive their assigned QR code, pick up space # required by Fire Marshal, aprons, and tip jar QR codes for fundraising.

BBQ PITS

Any commercial or homemade pit or smoker, trailered or untrailered, may be used if it is typically designed for competitive barbecue.

- Pits may use gas or electricity only to ignite wood or wood products, not for cooking.
- They must be of permanent design with separate cooking chambers and heat sources (no shared heat).
- Pellet smokers and electrical accessories (such as spits, augers, or forced drafts) are permitted.
- Heat lamps, proofing cabinets, or electrical heating/holding devices are not allowed.
- Sous vide, boiling, or frying of competition meat is prohibited.

COOKED ONSITE

Each team must provide its own pit(s) and use them exclusively within their assigned cooking site. All preparation and cooking of competition meats (except pre-trimming) must occur on-site and within the designated competition time frame.

Once a team and their CBA meats arrive at BBQ Austin, the meats may not be removed from the competition grounds.

Pre-trimming is allowed and meats may be removed from store packaging for this purpose.

CBA SCORING - QR CODES

Each turn-in tray will have a taped QR code affixed to the top, scanned at pickup, and assigned to your team.

Teams are responsible for the care of their trays.

- Damaged trays with the QR code still attached will be replaced by a CBA representative.
- Lost trays will not be replaced, and the team will receive a score of zero in that category.

A 10-minute window before category turn-in will be enforced. No late entries will be accepted.

CONTEST TURN-IN TIMES

A 10 minute window before category turn-in time will be recognized and enforced. **No late entries will be accepted.*

TEAM DISQUALIFICATIONS

Failure to comply with CBA rules may result in disqualification of the team. This includes, but is not limited to:

- Use of foul, abusive, or unacceptable language by a head cook, team members, or guests.
- Failure to follow event or city regulations.
- Failure to comply with any state, city, county, or CBA COVID-19 guidelines.

CONTEST COOKING & AWARDS

- Each sample is evaluated on its own merit, not compared to other samples.
- The samples will be scored by judges on the basis of presentation, taste, and texture.
- The highest score in each meat category will be awarded category winner.
- The highest overall combined score for Brisket, Ribs, and Chicken is awarded the BBQ Austin Grand Champion.
- All garnishes and condiments are prohibited (beans are the only exception).
- Sauces and/or other liquids may not be added to the tray prior to placing the product in.
- Meats may be cooked with sauces and/or other liquids, but once the cooking is complete, sauces and/or liquids may not be added once the protein has been placed in the tray.
- Foreign items (toothpicks, pins, string, etc.) found in entry will result in disqualification.
- Entries not cooked to USDA safe minimum internal temperatures could also cause disqualification.
- Each tray will include one sheet of foil placed unfolded under the contents of the tray.
- After the tray has been turned in, any tray found to be in violation of CBA rules will be disqualified at the discretion of the CBA Event Representative.
 - The CBA Event Representative will have the ultimate decision in disqualifying said tray.

JUDGING

- All entries will be judged on **PRESENTATION, TASTE, and TEXTURE.**
- The scoring system values will range from Excellent being the best score to Poor being the worst score.
- The weighting factors for the point system are as follows:
 - Presentation - **18%** (.72)
 - Taste - **46.5%** (1.86)
 - Texture - **35.5%** (1.42)
- Single Round Judging - CBA Event Representative will allocate a recommended amount of 10 entries to a table with six (6) approved judges. The lowest score out of the 6 judges will be dropped. The remaining 5 scores will be used to determine category placement.
 - Once all CBA categories and BBQ Austin categories are scored, those scores will be added together to determine overall placement.

**Please Note: Winners of contests that are awarded monetary winnings must fill out a W-9 and pick up their check.*

CHICKEN CONTEST

***REQUIRED CONTEST - 1 ENTRY PER CHIEF COOK ALLOWED**

- Chief Cooks will provide their own chicken.
- Chickens may be cooked however you choose, as long as they are cooked on the pit.
- Need enough for 6 judges.
- Tray may not contain shredded or pulled Chicken.
- No garnish allowed.
- Foil provided by CBA must be placed unfolded at the bottom of the tray.
- Cornish game hens are not allowed and will be disqualified.

BRISKET CONTEST

***REQUIRED CONTEST - 1 ENTRY PER CHIEF COOK ALLOWED**

- Chief Cooks will provide their own brisket.
 - Only one (1) meat will be judged per contestant.
- Pre-cooked, pre-salted, or pre-marinated meat is not allowed.
 - All prep work and cooking (other than trimming) must be done onsite at BBQ Austin.
- Brisket slices and/or burnt ends only.
- Need enough for 6 judges.
- No garnish allowed.
- Foil provided by CBA must be placed unfolded at the bottom of the tray.

(Helpful hint: Place the slices and/or burnt ends parallel to the hinge of tray lid, working your way forward).

RIB CONTEST

***REQUIRED CONTEST - 1 ENTRY PER CHIEF COOK ALLOWED**

- Chief Cooks will provide their own ribs.
- Ribs must be bone-in, individually cut.
- Only Pork Spare ribs, St. Louis cut or Baby Back ribs are allowed.
- Need enough for 6 judges.
- No garnish allowed.
- Foil provided by CBA must be placed unfolded at the bottom of the tray.

(Helpful hint: Place the ribs parallel to the hinge of the tray lid working your way forward until the bottom is filled. Start a top row placing the ribs parallel until the required amount is in the tray with the meat side up and bones pointing the same direction.)

BEAN CONTEST

- Beans will be started at the cooking site from dry pinto beans.
- Cooks may cook with condiments (this contest is the only exception for condiments).
- When the beans are turned in, nothing is to be included in the bean cup larger than the bean.
 - If something is found by the judges larger than a bean in the bean cup, the entry will be disqualified.
- Onsite entries will not be available for purchase.

DAVID KITCHEN JACKPOT CONTEST

- Contestants receive container for your "contest dish" which may be any type of "dish" cooked on a pit -- from rattlesnake to prime rib, anything goes (but no desserts)!!
- A team may enter more than one "contest dish", however, each additional "contest dish" costs an additional entry fee.
- Teams may begin cooking their Jackpot Cook-Off "contest dish" at any time, after arriving on the BBQ Austin Grounds.
- Onsite entries will not be available for purchase.

BLOODY MARY CONTEST

- The Bloody Mary entries will be judged on Presentation, Taste & Texture.
- Entry can be placed in any container, however no distinguishable marked containers, such as with the name of the team or team logo.
- Only vodka will be permitted as the alcohol ingredient. May use pre-mixed juices. Regular spices only.
- Bring entry to Judges Tent for contest check-in and judging.

BBQ SAUCE CONTEST

 - A sealed 12-ounce container labeled with product name and category type (see below) will be turned in for judging.
 - The label for all entries will be covered and assigned a random number to assure anonymity, before judging.

- **Traditional Sauce:** Tomato-Based, Mustard-Based, Vinegar-Based.

Rodeo Austin is not responsible for any refund between the registrant and a third-party vendor or for travel expenses.

In case of cancellation of the event or unavailability of the event due to war, governmental action or order, act of God, fire, Strike, labor disputes, or any other cause beyond Rodeo Austin's control, this Agreement shall terminate, and the exhibitor shall be entitled to the return of the fees for the event, less the prorated share allocated to Rodeo Austin of the expenses incurred by Rodeo Austin in connection with the event. Refund of the Fees as provided in this section shall be the exclusive remedy of the exhibitor against Rodeo Austin in case the event is canceled or rescheduled through war, governmental action or order, acts of God, fire, strike, labor disputes, or any other cause beyond the control of Rodeo Austin of and from all claims for damage and agrees that Rodeo Austin shall have no obligation except the above stated refund. Requests for refunds must be submitted to Rodeo Austin and are subject to the discretion of Rodeo Austin.

FORCE MAJEURE: Rodeo Austin is not liable for any delay or failure to perform its operations, activities, shows, and/or events to the extent such delay or failure results in a force majeure occurrence. A force majeure occurrence is defined as any occurrence arising from the causes beyond the reasonable control of Rodeo Austin that delays or prevents performance by Rodeo Austin otherwise required by this agreement, including but not limited to any

- Breakage or accident to equipment, machinery, or facilities
- Any strikes, lock-outs, or other labor difficulties
- Statutes, ordinances, regulations, orders, or rules issued by governmental authorities,
- Judicial decrees or orders
- Acts of God
- Animal diseases and/or quarantines
- Wars, riots, or insurrections
- Civil disobediences, public demonstrations, or sabotage
- Fires, floods, explosions, or inclement weather
- Inability to obtain necessary labor, materials, supplies, utilities, or transportation
- Depressions, recessions, or other economic downturns
- Embargoes or energy shortages
- Other causes beyond Rodeo Austin's reasonable control
